- We'll use the information you provide (and other personal data about you) to process your application and, if you are accepted, in connection with the internship programme and for certain purposes connected with the running of the University of Westminster, both while you are studying with us and after you have left. These purposes include managing relationships with you, complying with legal requirements to which we are subject, and fulfilling our obligations to you in relation to the internship programme. The University of Westminster will process your personal data in accordance with the General Data Protection Regulation and Data Protection Act 2018 and other related legislation as amended or superseded.
- If you are applying via your home university or via a sending organisation (for example an agent), information about you will be shared by the University of Westminster with your home university or sending organisation (for example an agent). The information that is shared will include information relating to your application, enrolment and any issues arising from your participation in the internship programme. We will also share information about you with your internship host company or organisation. If you, your home university or sending organisation (for example an agent) is/are outside of the European Economic Area, we will have to transfer information about you to the relevant country, where different data protection laws apply.
- If you are accepted and come to study at the University of Westminster, medical information about you
 may be disclosed to relevant staff including those from the Halls of Residence, the Counselling Service,
 the Advice Service and the Student Health Service. We may also transfer medical information about you
 to your internship host company or organisation.
- Personal data about you may also be transferred to third parties who provide services to the University
 of Westminster on the basis that it is provided in confidence and limited to those individuals who need
